

Notification of Sexual Offender Release

Note: The subject named in this press release is not wanted for any current offense. This notification is provided under the Sex Offender Notification Act to alert the public to a convicted sex offender that is believed to be a high risk to re-offend. This notification is not provided as punishment for the offender and the Bonney Lake Police Department will investigate any action by anyone as retribution towards the offender.

NAME: **POUNCY, CURTIS N**

LOCATION OF RESIDENCE: **188XX Mountain View Drive, Bonney Lake, WA 98391**

OFFENSES: Rape 1st Degree (1983), Rape 2nd Degree (1983), Unlawful Imprisonment, Felony Harassment, Assault (1998)

According to official documents, in 1982 Pouncy raped a 13 year old girl who accepted a ride from him at a Greyhound bus station in Seattle. In 1983, Pouncy raped a 19 year old woman who was unknown to him but accepted a date request and the next day went to his residence. Pouncy was convicted of both crimes and remained in prison until 1997. After his release, Pouncy attacked a 22 year old woman whom he met while walking and then invited into her apartment. The woman escaped his attack by jumping out her third story apartment window. Pouncy was committed back to Department of Corrections, McNeil Island. Pouncy has remained at the Secure Commitment Center (SCC) on McNeil Island after being committed as a Sexually Violent Offender on 10/16/2006. The court authorized his release to a less restrictive housing on 10/12/2010 to allow Community College attendance. During this time, Pouncy has participated in sexual deviancy treatment. After an annual review, the Department of Corrections authorized a less restrictive alternative release plan which will allow Pouncy to reside within the Bonney Lake community with his wife. Pouncy will remain under the supervision of Department of Corrections with multiple restrictions to include direct supervision of an approved monitoring adult, continued sex offender treatment, curfew restrictions and GPS monitoring.

Due to Pouncy's sexual criminal history, he has been classified as a Level 3 Sex Offender. This allows the Bonney Lake Police Department to disclose relevant, necessary, and accurate information to the public at large.
